- **Important Note:** It is your obligation to immediately contact the Season Pass office at Sugarloaf Mountain if the credit card used for your Resort AutoCharge is lost or stolen, or if the credit card number or details are changed in any way.

Applicant acknowledges this agreement is governed by the applicable laws of the State of Maine. In the event of the expiration or invalidity or applicant's credit card, or any failure relating to payment by the issuer thereof, applicant agrees to make payment of all amounts charged to applicant's season pass or any other season pass covered by this agreement. Applicant agrees to contact Sugarloaf Mountain immediately to notify of a lost or stolen credit card or any season pass covered this agreement or any change to credit card numbers or details.

Applicant agrees that Sugarloaf Mountain may pursue all avenues of collection, including the use of collection agencies; and applicant authorizes Sugarloaf Mountain to prepare and submit charge slips using any of the charge cards listed on this application to recover all charges and other unpaid amounts due.
