The Carrabassett Valley Fire Department wish to remind all condominium owners, tenants and renters that gas-fueled or open flame cooking grills/smokers/etc are not allowed on their decks or used underneath structures above. This practice is not allowed in any residential classification except detached one & two family homes. Additionally, cooking grills are not to be stored on decks within 10 feet of structures. LP Gas containers larger than 1 lb. cannot be stored inside a dwelling other than one and two family units.

The National Fire Protection Association Codes NFPA #1 and NFPA # 101 prohibit the above mentioned activity for the safety of users, neighbors and the dwelling structures. These codes have been adopted locally and statewide for many years.
